MP Investigations does not charge fees for reading plaintiff's deposition transcripts, that often holds a great deal of valuable information, useful for our surveillance.

RESULTS DRIVEN

Very rarely, if at all, will you find another company that does not charge for certain services, like we do. For example, there have been many times when we have not had a good physical address for a claimant. In cases like this, as soon as we learned that a claimant would be in attendance at places such as medical exam, hearing, deposition, etc. Realizing a potential one and only opportunity to develop a good address for that individual. We have utilized 2, 3, or even 4 investigators (In separate vehicles) at no extra charge to the client, to conduct surveillance of that subject. We do this to ensure our success in following that claimant through places like congested city streets to a good present physical address. (We routinely try harder than everyone else!)

As part of our surveillance assignments, we also conduct complete background checks/searches of the claimants which include social media searches. We never "just sit in front of someone's house" as mentioned to me in the past by an employee from a national vendor.
